**DEPARTMENT OF TAXATION YEAR-END WORKSHOP 2004  
ON OAHU AND THE NEIGHBOR ISLANDS**

HONOLULU—The Department of Taxation's Year-End Workshop 2004 series will begin on Tuesday, November 23, 2004, with its first session in Kona. The remaining workshops on Maui, Kauai, Oahu, and in Hilo will be held in December (see schedule on the following page).

All workshops begin at 8:30 A.M. and end at 12:30 P.M. Presentation topics include State tax form and other changes for the 2005 filing season, technical and policy issues, and State tax litigation, as well as a special presentation by the IRS on estate and gift taxes.

The cost for the workshop is \$60 for early registrations, and \$65 for late registrations. The cost includes a continental breakfast, workshop materials, and the 2004 Tax Information CD (to be mailed in early 2005). Four hours of Continuing Professional Education (CPE) credit also will be given. Workshop handouts can be separately ordered for \$15 a set.
