> THIS REPORT REFLECTS INFORMATION DISCLOSED IN THE REQUIRED NOTICE OF INTENTION SUBMITTED JANUARY 31, 1977 AND SUBSEQUENT INFORMATION FILED AS OF APRIL 27, 1977. THE DEVELOPER, BY NOTIFYING THE COMMISSION OF ITS INTENTION TO SELL, IS COMPLYING WITH THE REQUIREMENTS OF THE HORIZONTAL PROPERTY REGIME LAW, CHAPTER 514, HAWAII REVISED STATUTES.

- 1. Since the issuance of the Commission's Preliminary Public Report on "KAHE KAI I" condominium apartment project, Registration No. 898 dated February 21, 1977, the Developer has submitted additional information as of April 27, 1977. This Final Public Report is made a part of the registration of KAHE KAI I condominium project. The developer is responsible for placing this Final Public Report (white paper stock) in the hands of all purchasers and prospective purchasers along with a copy of the Preliminary Public Report (yellow paper stock). The Developer is responsible for securing from each purchaser and prospective purchaser a signed receipt, signifying that the purchaser or prospective purchaser has had an opportunity to read both reports.
- 2. The Developer of the project has submitted to the Commission for examination all documents necessary for the registration of a condominium project and issuance of this Final Public Report.
- The basic documents (Declaration of Horizontal Regime, Bylaws of the Association of Apartment Owners and a copy of the approved Floor Plans) have been filed in the Office of the Assistant Registrar of the Land Court of the State of Hawaii as Document No. 814142 and noted on Transfer Certificate of Title No. 122,502. The Condominium Map has been filed and designated as Condominium Map No. 230.
- 4. Advertising and promotional matter has been submitted to the Commission pursuant to its rules and regulations.
- The Developer advised the Commission that at the time the first apartment lease is entered into between the fee owner and an apartment purchaser, every mortgage and other lien affecting both such apartment and any other apartment shall be paid and satisfied of record, or the apartment being leased shall be released therefrom by partial release duly recorded.
- 6. The purchaser or prospective purchaser is advised to acquaint himself with the provisions of Chapter 514 of the Hawaii Revised Statutes and the Condominium Rules and Regulations which relate to Horizontal Property Regimes.
- 7. This Final Public Report automatically expires thirteen (13) months after date of issuance, May 5, 1977, unless a Supplementary Public Report is issued or the Commission, upon review of the Registration, issues an order extending the effective period of this report.

The information in the topical headings of the Preliminary Public Report issued February 21, 1977 has not changed except for DEVELOPER and the addition of BYLAWS.

DEVELOPER: The current officers of KAISER PACIFIC PROPERTIES CORPORATION are W. E. Ousterman, Jr., President; A. B. Brown, Jr., Vice President; G. J. Chavalas, Vice President; Ann L. Farley, Assistant Treasurer; Mary L. Glenn, Assistant Secretary; Carolyn Greenwald, Assistant Secretary; R. G. Hohnsbeen, Vice President and Controller; D. B. Hunn, Treasurer; B. F. Kaito, Vice President and Assistant Secretary; Clayton R. C. Kim, Assistant Secretary; Jack G. Nelson, Assistant Secretary; Edward E. Taggart, Assistant Controller; J. I. Walker, Vice President; and Carl R. Pagter, Secretary.

BYLAWS: According to Section 12 of Article II of the Bylaws, there are limitations on certain actions that may be undertaken by the Board of Directors unless the prior approval of the Secretary of Housing and Urban Development is obtained.

The Bylaws further provide that no dogs, cats, birds, livestock, poultry, rabbits or other animals whatsoever shall be allowed or kept in any part of the project except that the initial owners of apartment numbers F-104 and G-308 and the initial resident manager who resides in apartment number F-103 shall be permitted to keep the pets they own as of April 21, 1977 until such pet dies, is sold or given away or otherwise ceases to live at said initial owner's apartment.

The purchaser or prospective purchaser should be cognizant of the fact that this published report represents information disclosed by the Developer in the required Notice of Intention submitted January 31, 1977, and additional information filed on April 27, 1977.
