THIS REPORT REFLECTS INFORMATION DISCLOSED IN THE REQUIRED NOTICE OF INTENTION SUBMITTED OCTOBER 24, 1977 AND ADDITIONAL INFORMATION SUBSEQUENTLY FILED WITH THE COMMISSION AS OF OCTOBER 31, 1977. THE DEVELOPER, BY NOTIFYING THE COMMISSION OF HIS INTENTION TO SELL, IS COMPLYING WITH THE REQUIREMENTS OF THE HORIZONTAL PROPERTY ACT SET FORTH IN CHAPTER 514, HAWAII REVISED STATUTES.

1. WAIKIKI BANYAN is a proposed leasehold condominium project consisting of one (1) multi-family structure with twin towers of thirty-seven (37) stories comprised of eight hundred seventy-four (874) units. The Developer intends to sell the apartments together with an undivided interest in the commom

elements of the project. There will be a total of one thousand one hundred and eleven (1111) unassigned parking stalls (855 standard and 256 compact), located in parking decks designated one through five within the building. Each apartment will have appurtenant to it one (1) or two (2) parking stalls.

- 2. The basic documents (Declaration of Horizontal Property Regime, ByLaws of Association of Apartment Owners and a copy of the approved floor plans) have not been filed in the office of the recording officer.
- 3. This Preliminary Public Report is made a part of the registration on WAIKIKI BANYAN condominium project. The Developer is responsible for placing this Preliminary Public Report (yellow paper stock) in the hands of all purchasers and prospective purchasers and for securing a signed copy of the Receipt for Horizontal Property Regime Public Report from each prospective purchaser.
- 4. The Developer of the project has submitted to the Commission for examination all documents deemed necessary for the registration of the condominium project and the issuance of this Preliminary Public Report.
- 5. Advertising and promotional matter has not as yet been submitted pursuant to the rules and regulations promulgated by the Commission.
- 6. The purchaser or prospective purchaser is advised to acquaint himself with the provisions of Chapter 514, Hawaii Revised Statutes and the Condominium Rules and Regulations which relate to Horizontal Property Regimes.
- 7. This Preliminary Public Report automatically expires thirteen months after date of issuance, November 2, 1977, unless a Supplementary Public Report is issued or the Commission, upon review of the registration, issues an order extending the effective period of this report.

DESCRIPTION: The proposed project consists of 105,576 square feet parcels of land situated at Hamohamo, Waikiki, Honolulu, Hawaii, with improvements to be constructed thereon consisting of one (1) multi-family structure having two 37 story towers, designated as the "Makai Tower" and "Mauka Tower", both without basements. Said structure is constructed principally of reinforced concrete columns, floor slabs, shear walls and roof, with non-load bearing partition walls of steel stud and gypsum board and aluminum frame glass windows.

NOTE: The Condominium Map reflects that both "Makai" and "Mauka" Towers partly include and partly rise above a 6-story multi-purpose structure, together with parking facilities.

APARTMENT TYPES: There will be seven (7) types of apartment units which have been designated, for classification purposes only as Model "A", "AR", "B", "C", "D", "E" and "F". The descriptions of said types of apartment units are more fully described as set forth in Exhibit "B", attached hereto and incorporated herein by reference.

All units will be furnished with wall to wall carpeting in the living room-dining room area, dressing room area and bedrooms. The kitchen and bathroom floors will be covered with vinyl asbestos. The appliances included with each unit are a continuous clean range-oven with hood and fan, a frost-free refrigerator-freezer with automatic ice maker, a garbage disposal and trash compactor, A/C units. Counter tops will be constructed with post form Formica.

The numbers of the apartment units, their location and type are shown on Exhibit " ", attached hereto and incorporated herein by reference.

COMMON ELEMENTS: One freehold estate is hereby designated in all of the remaining portions and appurtenances of the project herein called the "common elements" including specifically, but not limited to:

- (a) Said land in fee simple;
- (b) All foundations, floor slabs, columns, girders, beams, supports, unfinished perimeter, party and load-bearing walls, roofs, entries, stairways, elevators, walkways, entrances and exits of said building;

- (c) All yard, grounds and landscaping;
- (d) All parking areas;
- (e) All pipes, cables, conduits, ducts, fan rooms, electrical equipment, wiring and other central and appurtenant transmission facilities and installations over, under and across the project which serve more than one apartment for services such as power, light, gas, water, sewer, telephone and television signal distribution, if any;
- (f) Two (2) utility rooms on each of the fourth and fifth floors of the Mauka Tower and fourth and fifth floors of the Makai Tower;
- (g) A patio, swimming pool, two lounge areas, patio, men's and women's restrooms and wet bar located on the sixth floor of the Mauka Tower and a utility room, men's and women's restrooms, two lounge areas, a laundry room, housekeeping room and mechanical room on the sixth floor of the Mauka Tower, with a recreation deck on the roof of the garage connecting the Mauka and Makai Towers.
- (h) Housekeeping and mechanical rooms located on each of the seventh through twelfth and fourteenth through thirty-seventh floors of the Makai Tower and the seventh through twelfth and fourteenth through thirty-eight floors of the Mauka Tower;
- (i) Jogging Track on the roof of each of the Mauka and Makai Towers.

LIMITED COMMON ELEMENTS: The Declaration states that there are no "limited common elements" thereby designated and set aside for the exclusive use of certain apartments.

COMMON INTEREST: Each apartment shall have appurtenant thereto an undivided 1/874 fractional interest in all common elements of the project (herein called the "common interest", and the same proportionate share in all common profits and expenses of the project and for all other purposes including voting.

<u>USE</u>: The apartments shall be occupied and used only for <u>purposes</u> permitted from time to time by applicable zoning ordinances rules and regulations, and for no other purpose. The owners of the respective apartments shall have the absolute right to lease such apartments subject to all provisions of the Declaration of Horizontal Property Regime and the By-Laws attached thereto.

OWNERSHIP: According to a Preliminary Report issued by Aloha Title Co., Inc. on October 21, 1977, title to the land committed to the project is vested in the Trustees of the Liliuokalani Trust, as Parcel First, and Kawaiahao Church, as Parcel Second.

ENCUMBRANCES AGAINST TITLE: Said Preliminary Report also reflects that the following encumber the limited common elements, the apartments and common elements:

- 1. AS TO PARCEL FIRST ONLY: A Grant of Easement designated as Easement 3 on State Land Surveyor's Map filed with Land Court Application No. 1865 (pending), in favor of the City and County of Honolulu and the Board of Water Supply, for sewer line and water main purposes, dated December 11, 1925, recorded in the Bureau of Conveyances of the State of Hawaii in Liber 1038, Page 23.
- 2. AS TO PARCELS FIRST AND SECOND: Real property taxes (Oahu) for the fiscal year 1977 1978 are a lien, payable as follows:

1st Installment - Paid 2nd Installment - Open (Delinquent after February 20, 1978)

3. Title to all minerals and metallic mines reserved to the State of Hawaii.

EASEMENTS: In addition to the above, the apartments and common elements shall also have and be subject to the following easements:

- 1. Each apartment shall have appurtenant thereto non-exclusive easements in the common elements designed for such purposes for ingress to, egress from, utility services for and support of such apartment; in the other common elements for use according to their respective purposes, subject always to the exclusive use of the limited common elements as provided herein; and in all other apartments of the building for support.
- 2. If any part of the common elements now or hereafter encroaches upon any apartment or limited common element, a valid easement for such encroachment and the maintenance thereof, so long as it continues, shall exist. In the event the building shall be partially or totally destroyed and then rebuilt, minor encroachments of any part of the common elements due to construction shall be permitted, and valid easements for such encroachments and the maintenance thereof shall exist.
- 3. Each apartment shall be subject to an easement in favor of the owners of all other apartments for access to any common elements located in such apartment.

PURCHASE MONEY HANDLING: An Escrow Agreement dated October 25, 1977, has been executed and a copy of same has been filed with the Commission. The Escrow Agent is Aloha Title Company, Inc., a Hawaii corporation. Upon examination, the Specimen Sales Contract and the executed Escrow Agreement

are found to be consonant with Chapter 514, Hawaii Revised Statutes, and particularly Sections 514-15(6) and 514-36 through 514-40.

The Specimen Sales Contract provides among other provisions that Purchaser agrees that all rights of Purchaser are and at all times shall be subject and subordinate to the lien of any mortgage to a lending institution, and to all advances, modifications, extensions and renewals thereof, made to finance the cost of construction of the project. Further, the Specimen Sales Contract provides, in part, that in the event less than seven hundred (700) apartments are sold prior to December 31, 1978, Seller may at its option cancel this Agreement, in which event Seller will cause Escrow to refund all monies paid by Purchaser, without interest, and less Escrow's cancellation fee and Seller shall be relieved and released of all further liability thereunder.

It is incumbent upon the prospective purchaser that he reads with care the Sales Contract and the executed Escrow Agreement. The latter Agreement establishes how the proceeds from the sale of condominium units are placed in trust as well as the retention and disbursement of said funds.

MANAGEMENT AND OPERATIONS: The By-Laws of the Association of Owners vest the Board of Directors with the powers and duties necessary for the administration of the affairs of the project.

The initial Managing Agent shall be Dillingham Land Corporation, 1441 Kapiolani Boulevard, Honolulu, Hawaii 96814. A Specimen Management Contract with Dillingham Land Corporation has been submitted.

STATUS OF PROJECT: The Developer has advised the Commission that the project has not commenced construction and the estimated date of completion is June or July, 1979.

NOTE: The Developer advises that pursuant to Paragraph 29 of the Specimen Condominium Reservation Agreement the purchaser shall agree that until Developer has closed out the sale of all apartments in Project or until December 31, 1982, whichever shall first occur, the purchaser will not enter into a "rental pool" or similar agreement with any purchaser, lessee or owner of another apartment in the Project and/or any third party.

The purchaser or prospective purchaser should be cognizant of the fact that this Public Report represents information disclosed by the Developer in the required Notice of Intention submitted October 24, 1977 and information subsequently filed on October 31, 1977.


