- 1. Since the issuance of the Commission's Preliminary Public Report of October 4, 1978, Registration No. 1024, the Developer has prepared and forwarded additional information to the Commission.
- 2. The Developer has submitted to the Commission for examination all documents necessary for the issuance of this Final Public Report.
- 3. No advertising or promotional matter has been submitted pursuant to Chapter 514A of the Hawaii Revised Statutes and the rules and regulations promulgated by the Commission.
- 4. The Developer advises that the Declaration of Horizontal Property Regime, with By-Laws of Association of Apartment Owners attached, dated July 18, 1978, has been recorded in the Bureau of Conveyances of the State of Hawaii in Liber 13360, Page 371. The Condominium Map has been filed in said Bureau as Condominium Map No. 584.
- 5. The purchaser or prospective purchaser is advised to acquaint himself with the provisions of Chapter 514A of the Hawaii Revised Statutes, the Horizontal Property Act and the Condominium Rules and Regulations which relate to Horizontal Property Regimes.
- 6. This Final Public Report is made a part of the registration of "THE SOVEREIGN" condominium project. The Developer is responsible for placing this Final Public Report (white paper stock) and the Preliminary Public Report (yellow paper stock) in the hands of all purchasers, and for securing a receipt for such Reports.
