- 1. Since the issuance of the Commission's Preliminary Public Report on THE WINDSURFER condominium, dated May 16, 1984, the Developer has submitted additional information deemed material to the Project.
- 2. The Developer has filed all documents and exhibits deemed necessary by the Commission for the registration of the Horizontal Property Regime and the issuance of this Final Public Report.

- 3. Promotional materials have been submitted pursuant to the Rules and Regulations promulgated by the Commission.
- 4. The Declaration of Horizontal Property Regime and By-Laws of Association of Unit Owners have been recorded in the Bureau of Conveyances of the State of Hawaii, at Liber 18240, Page 101. The floor plans and elevations (herein "Condominium Map") has been recorded at said Bureau of Conveyances and has been assigned Condominium Map No. 929.
- 5. The purchaser or prospective purchaser is advised to acquaint himself with the provisions of Chapter 514A of the Hawaii Revised Statutes and the Condominium Rules and Regulations which relate to Horizontal Property Regimes.
- 6. This Final Public Report automatically expires thirteen (13) months after date of issuance, July 5, 1985, unless a Supplementary Public Report issues or the Commission, upon review of the registration, issues an order extending the effective period of this report.
- 7. This Final Public Report is made a part of the registration of THE WINDSURFER Condominium project, Registration No. 1599. The Developer is responsible for placing the Final Public Report (white paper stock) along with a copy of The Preliminary Public Report (yellow paper stock) and Disclosure Abstract in the hands of all purchasers and prospective purchasers and securing a signed receipt therefor.
